

## Martin Luther King, Jr. Day Parade Rules and Regulations

### Christ Community Connection, Inc.

1. The parade is to be held on Saturday, January 13, 2018 at 10 AM There is no charge to Participate in the parade, but a signed Parade Entry Contract and Release form is required and must be completed to advise us as to who will be responsible for each group. No entry fee for parade.
2. Banners and/or signs may be displayed (3' x 5' is the maximum size of all signs).
3. Parade assembly area will be barricaded early Saturday morning before the parade. NO vehicles except those in the parade will be allowed in the area. A diagram of the parade route is enclosed. Please note the areas that have been designated as drop-off points.
4. In compliance with the Carrollton Police Department and Carrollton City Council, no child under age 11 may walk in the parade.
5. All Parade entries will assemble at the City Hall Parking Lot.
6. Parade participants must furnish their own posters, decorations, vehicles, masking tape, etc. The Parade committee does not furnish any of these times. All decorations are the responsibility of each entrant. Group identification is the responsibility of the group.
7. Line-up is at 8:00 AM January 13, 2018. The parade begins promptly at 10:00 AM. The responsible party of each group must appear by 9 AM to claim a space. You will forfeit your right to a specific space and be placed at the end of the line. Promptness by the responsible party and your group is imperative.
8. Absolutely NO CANDY THROWING from vehicles, or throwing of any items, souvenirs or otherwise.
9. There will be 4 awards presented to the floats or marching group that, in the opinion of the judges, displays the most energy and enthusiasm, along with "Christ Community Connection, Inc."
